

Environmental Politics

Miri Lavi-Neeman 3 weekly lecture hours, 3 credits. Undergraduate level.

Course description

We live at a time when planetary ecologies appear to be most threatened and vulnerable, and global environmental problems, from climate change, to biodiversity have become pressing political concerns for the global economy.

This class examines different international politics, actors, processes, and structures that have emerged in the arena of global environmental politics.

Topics include:

- Global and regional environmental problems, agreements and structures of governance
- The politics of climate change, water shortage, energy
- Actors, tensions, processes, and theories in global environmental politics.
- Grassroots environmental politics
- Special focus on the upcoming Paris World Climate Summit December 2015

Part 1 of the course sets the context, assessing the history and current state of global environmental politics,

Part 2 introduce tensions in environmental politics introducing the language of environmental justice, and examining the roles of states, inter-state coalitions, business, and NGOs.

Finally in Part 3 we discuss grassroots environmental politics, the connection between global and local dimensions, and alternatives to the present framework of global governance.
